CDT Exam Locations

Applicants will select their certification exam site location after their application through CSI has been approved. Upon application approval, applicants will be sent instructions for selecting their test site approximately two months prior to the exam. Exam site locations will be selected directly through Prometric, the company handling the computer-based testing. To see a listing of possible testing locations visit www.prometric.com/CSI.

Additional CSI-sponsored exam sites, dates and locations will be posted at www.csinet.org/certification.

Certification Policies

Candidates who are unsuccessful in passing an exam may retest after at least 90 days. Retesting requires a new CDT Examination Application and registration fee.

Candidates who are unable to sit for an exam may request a cancellation and refund of the application fee.

- Cancellation requests received *14 days prior* to the first day of the test window will be refunded 100% of the exam fee.
- Cancellation requests received *less than 14 days prior* to the first day of the test window will be refunded 50% of the exam fee.
- Cancellation requests received *less than 5 calendar days prior* to the first day of the test window will not be refunded the exam fee.

A scheduled exam appointment with Prometric must also be cancelled through Prometric via www.prometric.com/CSI or 1-800-503-8991. Candidates who do not request a cancellation and do not sit for the exam forfeit all fees. Application fees may not be transferred to another individual. Candidates who wish to sit for the next exam must submit a new application and fee.

CSI's CDT certificate exam is a rigorous test of knowledge, but is not a guarantee of future performance quality or capabilities of certified individuals.
